The Journal of Medicine and Pharmacy, established by Can Tho University of Medicine and Pharmacy, annually publishes 10 issues. The contents focus on 3 main sections: 1) Original articles from scientific research topics; 2) Reviews on aspects of Basic Sciences and Health Sciences for educational purposes'; 3) Insights into current mainstreams of research including Basic Sciences such as Chemistry, Physics, and Biology, or Health Sciences such as Medicine, Pharmacy, Pharmaceutical Sciences, Biomedical Sciences, and Public Health

1. Requirements for Formats:

- 1.1 All articles must be written by Microsoft Words in A4 size;
- 1.2 Submitting using Unicode; Font: single, size 12 Times New Roman; About the title of every article: font size 13, Uppercase, Bold, and Center; About author(s) and other contributors (et al.): Italic, Align Right, No Academics Ranks, Degree or Roles included; The abstract: Italic, no bold; The title of each section: Bold, numbering through Roman Numerals from I to V;
- 1.3 Margins: Left 3.5 cm, Right 2.5 cm, Top 3 cm, Bottom 3 cm;
 - 1.4 Page number: at the bottom center of the page;
- 1.5 The article must include a structured ab stract of 200-250 words with the tags or keywords;
- 1.6 The first page must contain some necessary sections such as title, authors' names and affiliations, contact details of the corresponding author (email or phone number).

2. Requirements for Contents

2.1. Scientific Research Articles (5-7 pages)

a. Abstract:

Must include the Introduction (consisting of the research purposes), Materials and Methods, Results and Conclusions. The keywords must be written following the formats of Medical Subject Headings (MeSH) of Index Medicus

- b. Overall Contents: made up of 5 different sections:
- I. Introduction: briefly show the comprehensive abstraction of topic and purpose of the research.
 - II. Materials and Methods
 - III. Results
 - IV. Discussion
 - V. Conclusions

References (up to 15 references).

2.2.Review Articles (up to 10 pages)

a. A review article does not need to have a similar structure as an original article, but still including necessary sections such as (1) Title, (2) Author(s) and affiliations, (3) Abstract, (4) Introduction,

- (5) Content, (6) Research prospects, (7) Conclusions, (8) Acknowledgement (if possible), (9) References (up to 15 references):
- b. The review article must include enough figure sources and references using in the article:
- c. Methods for displaying tables, graphs, diagrams, illustrations, terms, unit of measurements and references are similar to an original article.
- **2.3.** Updating Articles in Medicine, Pharmacy and Biomedicine: Each article must not exceed 3 pages and mention thoroughly the original sources, date and references (up to 10 references).

- Textbooks citation format: author(s), published year, title (*Italic*), Vol., publishing house, publishing place, pages from... to...
- Journal's citation format: author(s), year. Article's title. *Journal's title* (abbreviation following the conventions in Medline), Vol., first and last pages.
- Theses or dissertations citation format: author (year), title, academic ranks, Tuitions, address.

4. Submission fee:

- 4.1. Submission fee for the Vietnamese issue: VND 1,500,000/manuscript.
- 4.2. Submission fee for the English issue: Free of charge.
 - 4.3. Fee must be sent with the manuscript.
